Movement seen in coal talks

WASHINGTON — The United Mine Workers and the coal industry resumed contract negotiations Friday amid signals the union is softening its stand on a major issue that has stood in the way of a settlement.

The 39-member bargaining council, meeting separately before labor and management return to the table, failed to take any formal action on a resolution outlining the UMW's stand, even though union president Sam Church had said on Thursday such a resolution might be forthcoming.

Although Church insisted following a day-long meeting of the bargaining council that the union would be presenting the same issues to the Bituminous Coal Operators Association when talks resumed, there were indications from union sources that the UMW leaders were discussing a scaling down of the so-called "wage standards" clause designed to protect union members from the loss of jobs to non-union labor.

A half hour after the two sides returned to the bargaining table at a downtown Washington hotel, the industry negotiating team asked for time to caucus among themselves. Some movement was evident.
