JUNIOR FAIR UP-DATE

Lancaster- Earlier this week, Governor Mike DeWine ordered all Fairs scheduled after July 31st, 2020 to only have Junior Fair Programs. This involves no grandstand shows, rides, games, or large gatherings of people. In keeping with the Governor's order, the Fairfield County Fair will conduct only Junior Fair activities this coming October.

Governor DeWine along with the Fairfield County Agricultural Society Board of Directors understand the value and learning opportunities the Junior Fair provides the youth through their fair experience. Since March, the Board of Directors has been working on alternative plans should this situation occur. Our alternative plan outlines social (physical) distancing, sanitation procedures and scheduled activities that will limit large groups and the number of participants to insure youth exhibitors and their families' safety during the shows.

The Board of Directors are working with the Fairfield Department of Health to come up with detailed plans that will be shared with parents, youth exhibitors and Junior Fair volunteer participants. We ask for your patience as the situation continues to change daily. We assure you that we are working to provide the best and safest experience for all involved.
