NEXT BAND PRACTICE:

Monday 9-13-2021, 7:30 PM at Calvary UM church. 427 South Washington Street Circleville, Ohio

Bring your own music stand, and your practice music.

The church is at the corner of Washington Street and Mill Street.

Use the entrance off the alley behind the church (off Mill Street) with the ramp. That will be the only church door open, and that door will open right into our practice room.

Sherry and I should be there earlier than when any of you will arrive, so just walk up and go through the door. There aren't any windows in the door, so you won't be able to see any lights or activity from the parking lot.

You can park on the street, or in the parking lot behind the church.

I know of 3 new musicians who have contacted me and are interested in attending practice. We will certainly welcome them to the group.

9-13 PRACTICE MUSIC:

You should all have your practice music by now.

Please look through your new practice folder before 9-13 to make sure that your music is complete. Let me know if it is not.

LONG RANGE PLANS FOR THE BAND MUSIC FOR 2022:

FOLDER # 1:

The longer plan at this point for our music is to keep working from at least Folder # 1 *(the one we have been using since Memorial Day Week-end)* into 2022, but we will certainly take out some songs and add some from these practice pieces. The resultant folder may well be larger than the @ 40 songs that are currently there, but the benefit is that the paper

copies of the music will still be yours to take home and practice from, mark up as you need, etc. .

FOLDER # 4:

The other folder we have used this year, which was labeled Folder # 4, was the one that contains some marches along with the Americana *(Blue Cover)* Book that we have historically used for Memorial Day Observances.

Since that folder has marches, too, feel free to recommend any songs you would like added to that folder to perhaps give us more options during those performances.

I personally don't see a problem if there are duplicates in the two folders, as long as we have music in both that we like to play, and that would give us enough selections and choices for at our Memorial Day concerts, which at both Hallsville and Adelphi were close to 30 minutes long each location.

For any songs from our library that you want to examine at any point, let me know and we will work out how to get them to you so you can at least check them out. Possibly I can even either find, or create, sound files of them. The music library is the band's resource, not mine.

But, if we don't like to play them for whatever reasons, or we don't want to play them <u>again</u> because we have played them so often, then there doesn't seem to be any real reason to keep them in an active concert folder.

AVAILABILITY OF BAND SCORES:

For other reasons, I have been pulling out digital copies of all the scores I have found for the songs in our library. Almost all of these are condensed scores.

Roughly only @ 13% of the total songs we have in our library have Conductor's Scores available to us at this point.

In fact, in the main index of our music, I went ahead and included additional data fields of:

- a). Is this song listed as Public Domain?
- b). Is there a score available for this song?

For anyone who may have interests in seeing these specific scores, just let me know and I can send them to you.

Our band library is a tremendous resource, and I want to make it available to work <u>for</u> us and not just sit hidden and deteriorating in boxes.

WHY PRACTICE IN CIRCLEVILLE?

I take total responsibility for moving the band practice to Circleville as opposed to trying to continue having practice in either Adelphi or Hallsville. Hopefully this change will be beneficial to the band.

There are multiple, and I think significant, reasons I considered in order to come to this decision, many of which have already been shared in previous newsletters. But I am open to any additional questions there might be as to why this change.
